Final Instructions 1.

Dear Competitor.

All entries that have been received have been accepted.

An entry list in Class order will be available at scrutiny. The onus is on the Competitor to make sure that he or she is entered in the correct class for the event at Scrutiny.

Mechanical and Documentation Scrutiny will take place on Saturday morning at Bishopscourt (documentation at 'Rally Control', portacabin to your right as you enter service area) 07:00 hrs to 09:00 on Saturday 11th July 2015.

A Timing Strut MUST be fitted to the front of the vehicle as per MSA Yearbook S 10.9

A Drivers briefing will take place at 09:30 hrs on Saturday 11th July 2015 beside the control tower.

Competitors will be given the opportunity to run in a controlled convoy sighting run prior to the first official practice timed run. The convoy lap will start at 10:00 hrs.

There will be 2 Practice and 3 Official Timed Runs given on the day. Each run consists of 1.5 laps giving a total of approximately 2.9 miles in length.

The prize giving will take place in the bar area immediately after the event has ended and the results are final.

All Competitors will start in Class order starting with Class 1, 2, 3, etc and must be ready when called forward. There must be no speeding in the Paddock – 10 MPH MAX SPEED LIMIT!!

A large Spill Kit will be provided for the Paddock Area as per MSA Yearbook E 7.
